They must have completed their three years of full time experience *prior to taking the State exam*, and they must take their state exam, pass it, and submit their application for their broker's license to the REC within one year of the date they complete the broker's course. So for this course, which will end on November 20, 2008, a candidate would have until November 20, 2009 to complete their three years full time experience requirement, take their State exam and pass, and submit their application for their broker's license to the REC.
